FedID 2020 Virtual Conference Rules

Purpose

The objective of the Federal Identity Forum & Exposition 2020 is to further AFCEA's objectives by providing a forum through exhibits and technical panels. Sponsors are limited to firms, organizations and agencies whose exhibits are in harmony with the purpose of this Virtual Conference.

Eligibility

AFCEA has the sole right to determine the eligibility of any company or product for inclusion in the Virtual Conference.

Subleasing

Sponsor may not sublet his virtual exhibit space, nor any part thereof, nor exhibit, offer for sale, or advertise articles not manufactured or sold by the sponsoring company, except where such articles are necessary for proper demonstration or operation of the sponsors's virtual display, in which case identification shall be limited to the manufacturer's normal regular nameplate. Rulings of AFCEA shall, in all instances, be final with regard to use of virtual exhibit space.

Operation of Virtual Displays

Show Management reserves the right to restrict any virtual exhibit space which, in its sole opinion, detracts from the general character of the virtual conference. This includes display of unsuitable material as determined by Show Management to be objectionable to the successful conduct of the virtual conference as a whole.

Copyright Licensing

Sponsor is solely responsible for obtaining any required licenses to broadcast, perform, or display any copyrighted materials including but not limited to music, video, and software. Sponsor shall indemnify and hold harmless AFCEA, Show Management, and facility against cost, expense, or liability which may be incident to, arise out of or be caused by Sponsor's failure to obtain requisite license.

Cancellation by Sponsor

In the event of cancellation by a sponsor, AFCEA shall retain 100% of total virtual booth fee. AFCEA show management must receive written notification of the cancellation by email, registered or certified mail.

Limitation of Liability

The Sponsor is responsible for uploads and adding their content for their virtual exhibit space. Sponsor agrees to make no claim for any reason whatsoever against AFCEA, its employees, agents, or representatives.

Indemnification

The Sponsor shall defend, indemnify and hold Show Management harmless from and against all costs, claims, demands, proceedings, liability, losses and expenses (including reasonable legal fees) whatsoever made against or incurred by Show Management as a result of, related to or arising in connection with (i) a breach of these Terms by Sponsor, and/or (ii) any acts or defaults of Sponsor, your employees or agents in connection with the Event and/or (iii) any claim brought against Show Management that the Content or any services or software supplied by Sponsor infringe, violate, or trespass or constitute the unauthorized use or misappropriation of any intellectual property of any third party.

Waiver of Rights

Any rights of AFCEA under this contract shall not be deemed waived in any manner except as specifically waived in writing and signed by an authorized officer of AFCEA.

Amendment and Additional Rules

Any matters not specifically covered by the preceding rules shall be subject solely to the decision of AFCEA. AFCEA may, at any time, amend or add to these rules, and all amendments made shall be binding on exhibitor equally with the foregoing rules and regulations.

Agreement to Rules

Sponsor, for himself or itself, his or its personnel, employees, agents or representatives, agrees to abide by the foregoing rules and by any amendments and additional rules that may be put into effect by AFCEA.
